**PLEASE READ AND DISCUSS THE "RULES OF CAMP IVYDALE" (below) WITH YOUR CHILD SO THAT YOU ARE BOTH IN COMPLETE UNDERSTANDING OF THEIR MEANING AND CONSEQUENCES.**

1. "So in everything do unto others as you would have them do to you..." Matthew 7:12
2. The possession or use of tobacco, alcohol, or harmful drugs is strictly forbidden. All prescription drugs will be given to the Camp Nurse upon arrival at the campground.
3. No one is permitted to leave the campgrounds without the permission of the Director... if you are a minor, a member of the staff must escort you.
4. Swimming will be limited to only the scheduled times and with the proper safeguards.
5. The male and female residential areas are off-limits to members of the opposite sex, except as approved by the Director.
6. Activities not reflecting the character of Jesus (e.g. gambling or fighting) will not be allowed.
7. Profane, vulgar, or obscene language will not be tolerated.
8. Camp facilities will be kept clean and neat. You are responsible and liable for anything you damage or destroy.
9. All campers will dress modestly. Tank tops, cut-off or high-midriff T-shirts, short shorts, halter-tops, short skirts, and the like are not acceptable. Also, clothing reflecting anti-Christian themes is not acceptable. Director will decide if something is inappropriate. Please use common sense.
10. Electronic devices such as phone, radios, CD players, I-pods, and MP3 players are not allowed.
11. Items that could be harmful in anyway (e.g. knives, spiked collars, lighters, etc.) will not be allowed.
12. Dating relationships will be conducted in a Christian way. Appropriate conduct will be expected. Campers should come to camp with the goal of seeking God, not a boyfriend/girlfriend.
13. All campers are expected to follow the instructions of the camp staff members.

**THINGS TO BRING:** Bedding, Bible and notebook, towels, wash cloths and toiletries, mosquito repellent and flashlight. Clothing should include a jacket, sweatshirt and swimsuit. Bring clothing for the whole week; we have no laundry facilities available to campers.

**TO GET TO CAMP IVYDALE . . .** proceed from Boise toward Idaho City on State Highway 21. The Camp Ivydale **turnoff** is a mile or so **before** Idaho City, and is approximately 36½ miles from Boise. There is a large Welcome to Idaho City sign. At the turnoff, from the highway follow the main dirt road about a mile until you reach camp.

Parents and other adults are always welcome as visitors to camp. Our staff is pre-selected for each camp. To maintain our orderly atmosphere, **we request notice at the beginning of the week if you will be coming for a meal and we strongly discourage drop-ins who haven't received prior approval from the Camp Director.** **Overnight visitors will not be allowed.**
